

LUB Head Office - main areas

- 1) Manage the University document server
- 2) Give support and advice regarding scholarly communication and publishing
- 3) Give support and advice regarding copyright (in cooperation with the University Legal Division)
- 4) Administrative procedures to facilitate the transition to Open Access
- 5) Bibliometric service. On different levels map and evaluate the scholarly publishing produced by Lund University researchers.

Action plan

- Manage the University document server
 - Complete registration of LU's scholarly production
 - Facilitate annual reports, evaluations and comparisons of publishing output, researcher-CV:s, The "3d task" etc
 - Refereed scholarly articles in full-text (LU-research)
 - Doctoral dissertations (Scripta-database)
 - Scientific data raw data
 - Multimedia for education and research
 - Compendiums and other course material
 - Student theses (Xerxes-database)



Action plan cont.

- Administrate ScieCom The Swedish Resource Centre for Scientific Communication
- Give support and advice regarding copyright
 - Standard agreements for publishing
 - Cooperate with SUHF for national copyright agreements
 - "Copyright a short manual for Lund University Libraries"
- Help Desk for publishing. Information on
 - Refereed OA journals DOAJ www.doaj.org
 - Journals/publishers offering OA on article level
 - Article fees and publishing conditions (copyright, embargo times, allowed versions, membership etc)
 - Status and usage:Impact factors, no of downloads etc



Administrative procedures facilitating a transition to Open Access

- Managing article fees for Open Access
 - Separate article fees Hybrid models
 - Member fees for publishing services (e.g. BioMed Central)
 - Member fees eliminate or reduce article fees
 - Accounting of costs per publishing service and faculty
- Bibliometric service for evaluation and followup of LU's scholarly production
 - Locally at faculty-, departmental-, or individual level
 - International comparisons and evaluations- ranking lists
 - Map international cooperation, clusters, research fronts
 - Special focus on Open Access publishing



IPR-agreements

Transfer of copyright = market power

- Working group with representatives from the Law Faculty, the University Legal Department, and the Library Head Office have proposed model licenses for Lund University www.lu.se/jurenh/INTERN/avtal.html
- The Association of Swedish Higher Education (SUHF) has sent the Proposal for consultation to all Swedish universities. Very positive response. Task group appointed.

§ 2 Author's right to use the Article

Copyright remains with the Author. This will be acknowledged by the Publisher in the copyright line.

The Author retains the right to use the Article:

- for research, educational or other purposes of the Author's university/institution
- mounted on a server within the Lund University's domains (posted to free public servers of preprints and/or articles in the Author's subject area)
- in whole or in part, as the basis for further publications or spoken presentations
- for publication in the Author's future doctoral thesis / dissertation provided the Author acknowledge the original Article in standard bibliographic citation form.

The Association of Swedish Higher Education and the Berlin Declaration

- The Association o Swedish Higher Education has made the following recommendations to its members in order to implement the Berlin Declaration:
- 2. Introduce a policy that strongly recommends (*Berlin3* "*require*") that their researchers deposit a copy of each published article in an open digital archive
- 3. Encourage researchers to publish their research articles in Open Access scholarly journals if a suitable such journal is available and give the necessary support to make this possible
